

Pancakes for Peace

Questions/conversation starters

Recipe (based on BBC Good Food)

100g (3 ½ oz) plain flour 2 eggs 300ml milk – plant or diary both work well 1tbsp oil, plus extra for cooking pinch salt

Method:

Grace for Shrove Tuesday

Loving God, on pancake day
We'd like to send a prayer your way.
That we won't be flippant or flat with defeat,
Hearts of love and not concrete;
A kind, brave ox, a gentle kitten
On this pancake day, may we all be Shriven.

- 1. Put the flour and a pinch of salt into a large mixing bowl and make a well in the centre. Crack the eggs into the middle, then pour in about 50ml milk and 1 tbsp oil. Start whisking from the centre, gradually drawing the flour into the eggs, milk and oil. Once all the flour is incorporated, beat until you have a smooth, thick paste. Add a little more milk if it is too stiff to beat.
- 2. Add a good splash of milk and whisk to loosen the thick batter. While still whisking, pour in a steady stream of the remaining milk. Continue pouring and whisking until you have a batter that is the consistency of slightly thick single cream.
- 3. Getting the right thickness: Heat the pan over a moderate heat, then wipe it with oiled kitchen paper. Ladle some batter into the pan, tilting the pan to move the mixture around for a thin and even layer. Leave to cook, undisturbed, for about 30 seconds. If the pan is the right temperature, the pancake should turn golden underneath after about 30 seconds and will be ready to turn.
